CONTEST: October 2024 – Win your Soleil Stay!
RULES AND ENTRY CONDITIONS

1. ELIGIBILITY

To be eligible for the Contest, an individual must reside in Quebec and be 65 years of age or older. Any person aged 18 or older may register one of their relatives for the Contest, with their prior consent, provided that the relative meets the eligibility requirements listed in these rules. Employees, agents, and representatives of the Contest Organizers or any other individuals directly involved in the organization of this Contest, as well as their immediate family members (siblings, children, parents), their legal or common-law spouses, and all individuals with whom these employees, agents, and representatives reside, are excluded. Participants must have visited a Résidences Soleil Manor between October 1 and October 31, 2024, and must have filled out a Contest entry form.

2. PERIOD

The Contest "October 2024 – Win Your Soleil Stay" (hereinafter referred to as the "Contest") is organized by the marketing department of Les Résidences Soleil – Groupe Savoie (hereinafter referred to as the "Contest Organizers").

3. HOW TO PARTICIPATE

To participate in the Contest, participants must meet the eligibility requirements outlined herein. All customers who visit one of the Résidences Soleil between October 1 and October 31, 2024, and complete a Contest entry form are automatically eligible for the Contest.

4. DESCRIPTION OF THE PRICE

A Soleil stay of one week for two people

The winner will be offered a short stay of one week for two people or two weeks for one person in the Résidences Soleil of their choice, among all Résidences Soleil (excluding Les Résidences Soleil Manoir Repentigny) across Quebec, including a package of three meals per day and unlimited access to a wide range of activities, events, and amenities at the selected Résidences Soleil. The same rules established for the Contest apply, and the winner must comply with them; otherwise, the Contest Organizers reserve the right to cancel the prize. These rules are available by contacting the selected Résidences Soleil.

The prize must be accepted as described in these Rules and cannot, at the winner's request, be exchanged in whole or in part for cash and/or transferred to another person. If the winner declines the prize, the designation of a new winner remains at the discretion of the Contest Organizer.

Minimum total value of the Prize: \$1,050.

5. DESIGNATION OF THE WINNER

A winner will be randomly drawn by a member of the Savoie Family, owner of Les Résidences Soleil – Groupe Savoie, every day from all eligible Contest entry forms completed on that same day. Draws will take place every following morning starting at 11:00 AM (EST) at the Résidences Soleil Manoir Boucherville. Winners will be announced on the website www.residencessoleil.ca daily (except weekends).

Any participant selected in accordance with these Rules will be contacted by the Contest Organizer and will be declared the winner, subject to fulfilling all conditions described herein, complying with the participation Rules, and being reached by phone within 5 days of the random selection. If any of the conditions stated in these Rules are not met, the selected person's entry will be canceled, and a new draw for that prize will be conducted in accordance with these Rules until a participant is selected and declared the winner.

The refusal of a randomly selected person to accept a prize under the terms of these Rules releases the Contest Organizer from any obligation related to that prize towards that person.

The winner will be informed by phone about the details regarding the Prize. The winner must claim their Prize according to the instructions provided herein.
